#### **PROCEDURE**



#### 1) Initial Consultation and needs Analysis:

The process begins with an initial consultation where the escrow officer understands the client's needs and objectives.

A comprehensive needs analysis is conducted to determine the appropriate escrow services that meet the client's requirements.



#### 2) Offer Phase:

Based on the needs analysis, the trustee prepares a customized offer with the proposed services, the scope of the work and the corresponding costs.



#### 3) Conclusion of Contract:

Once the offer has been approved and all details have been clarified, the contract is concluded between the client and the escrow agent. The contract defines the duties and responsibilities of both parties.




#### 4) Execution of Services:

The escrow agent performs the agreed services in accordance with the contract. This may include the management of assets, the execution of transactions, the fulfillment of tax obligations or other tasks.



#### 5) Regular Reporting and Communication:

During the service period, the escrow agent shall keep the client regularly informed of progress. Financial reports, transaction reports or other relevant information are made available to the client, to ensure transparency and trust.



### 6) Monitoring and Adaptation:

The trustee continuously monitors the client's financial situation and, if necessary, adjusts the strategies to meet changing market conditions or changing client objectives.



### 7) Completion and Aftercare:

At the end of the service period or after completion of the agreed tasks, a final evaluation and settlement is carried out. If required, the escrow agent will also provide follow-up support to ensure that all aspects have been properly completed and to discuss possible future needs of the client. It is important to emphasize that each escrow service is tailored to the specific needs and objectives of the client, so the process may vary depending on the situation.




